If the Defendant fails to comply with any or all of the terms stated above, a conviction will be entered, a FINE of \$ \_\_\_\_\_ will be assessed, and the bond money will be applied to the fine. Any fine amount remaining will be immediately due and payable, and if the balance is not paid within 30 days after the deferral period expires, a warrant for Defendant's arrest may be issued and Defendant's Driver's License may not be renewed until this case has been finalized with the Court.
